

Declaration of conformity to REACh – regulation (EU No. 1907/2006)

In accordance to EU regulation No. 1907/2006 (REACh-Directive), dated 18th December 2006, Schulte Elektrotechnik GmbH & Co. KG acts as downstream user (manufacturer of products).

According to information from our suppliers, our products do not contain substances from the list of candidates (SVHC-list) dated February 4th 2026 in a concentration of more than 0.1% mass.

Components assembled into our products or sold as accessory can as a single component contain more than 0.1% mass of the following substance:

Declaration to PAHs (Polycyclic Aromatic Hydrocarbons)

According to present knowledge, we declare that the products Schulte Elektrotechnik GmbH & Co. KG places on the markets do not contain Polycyclic Aromatic Hydrocarbons, respectively contain less than the defined permitted maximum concentration limit, according to PAH-document.
